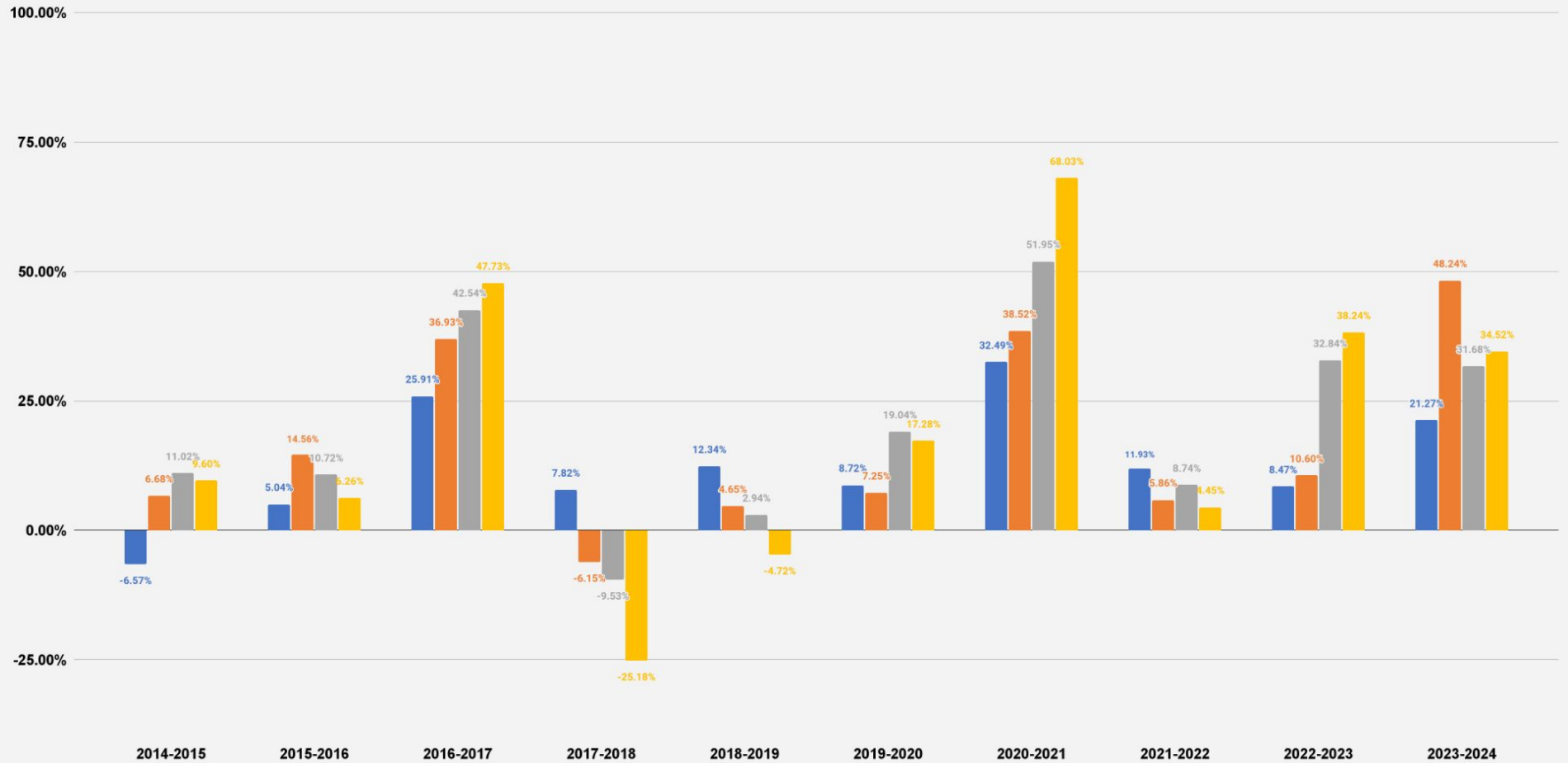

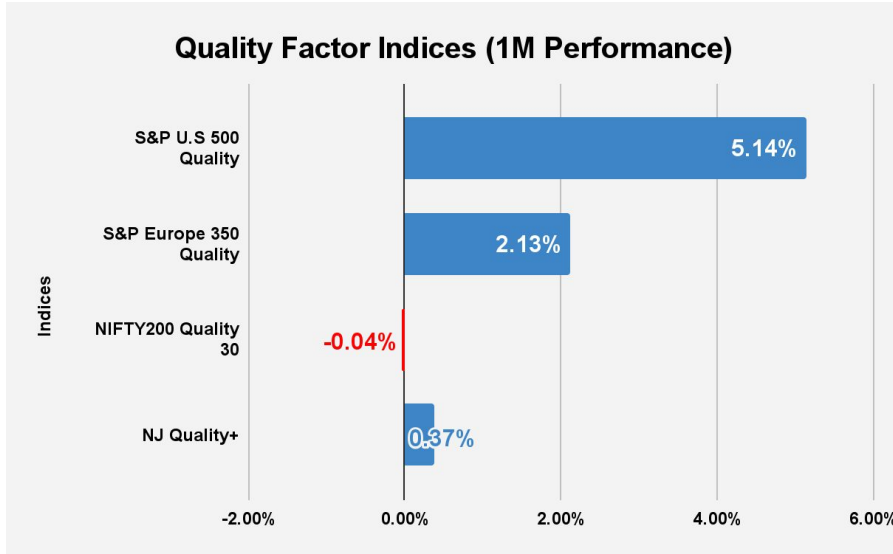

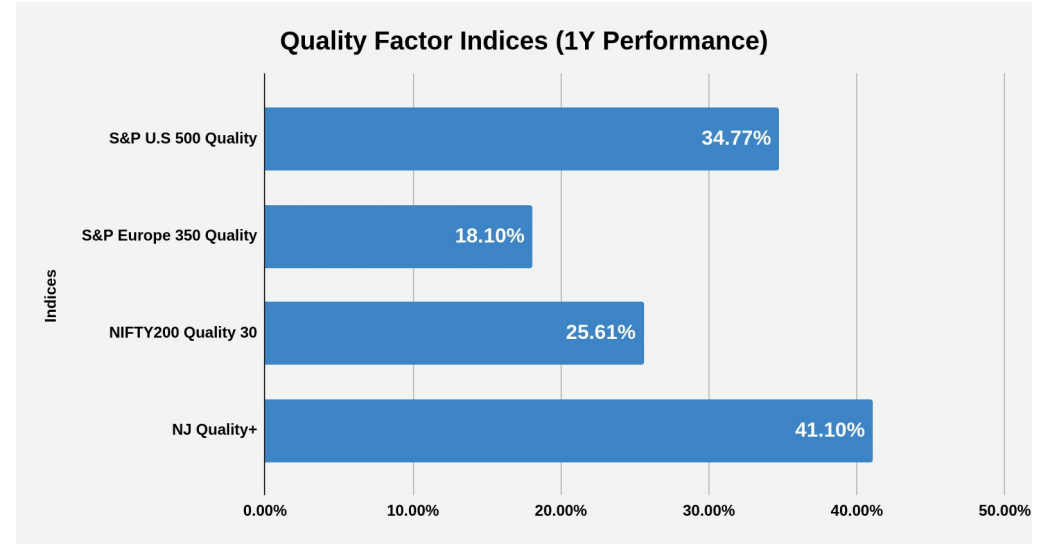

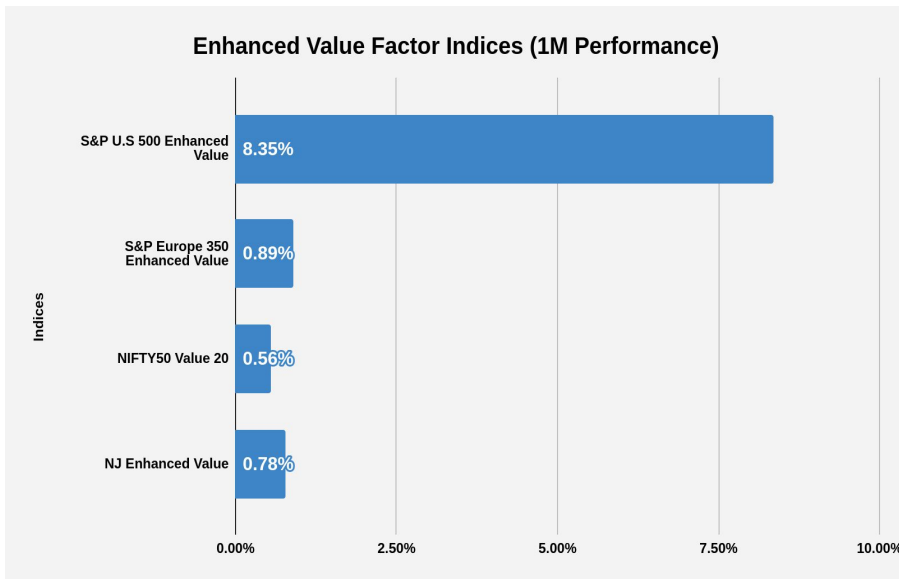

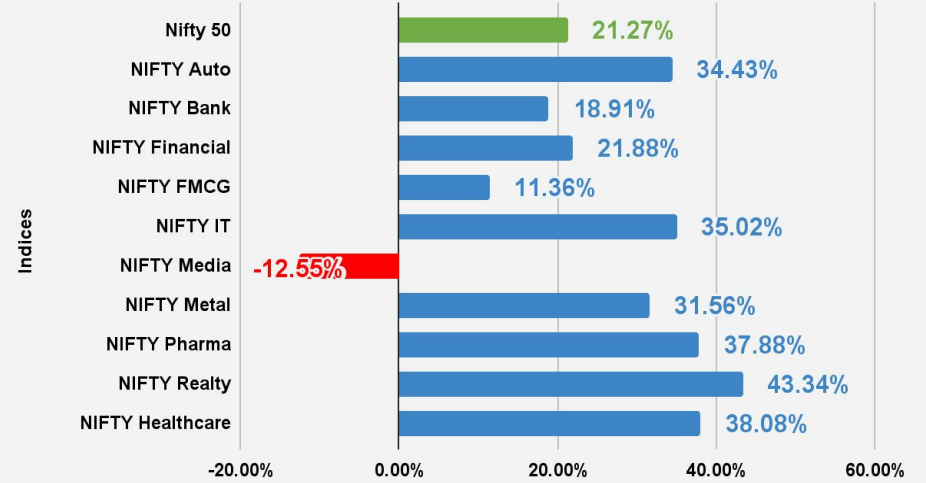


## Domestic Sectoral Indices (1M Performance)



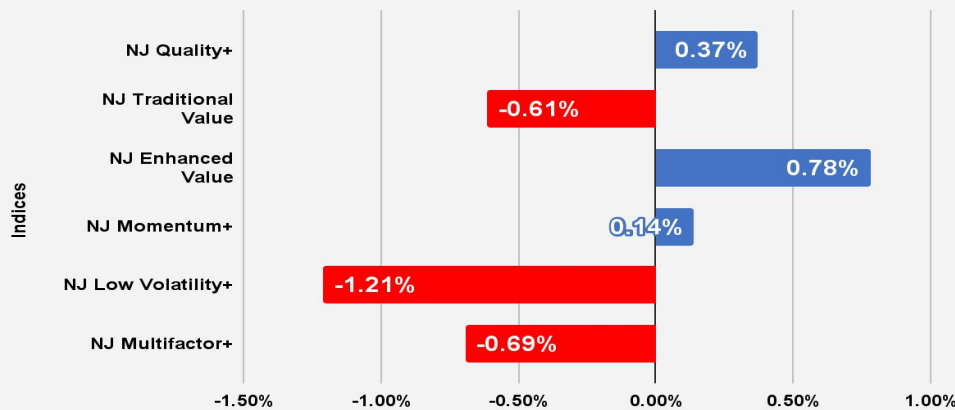

## Domestic Sectoral Indices (1Y Performance)



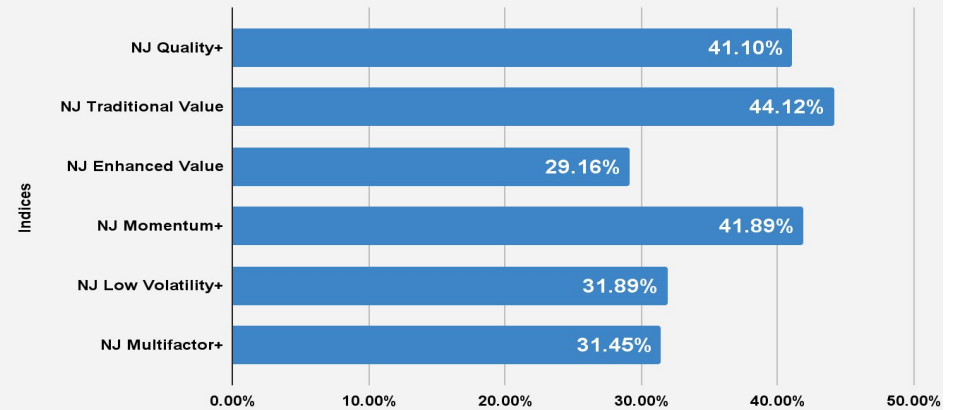

### India 3-Year Gov. Bond Yield (%)



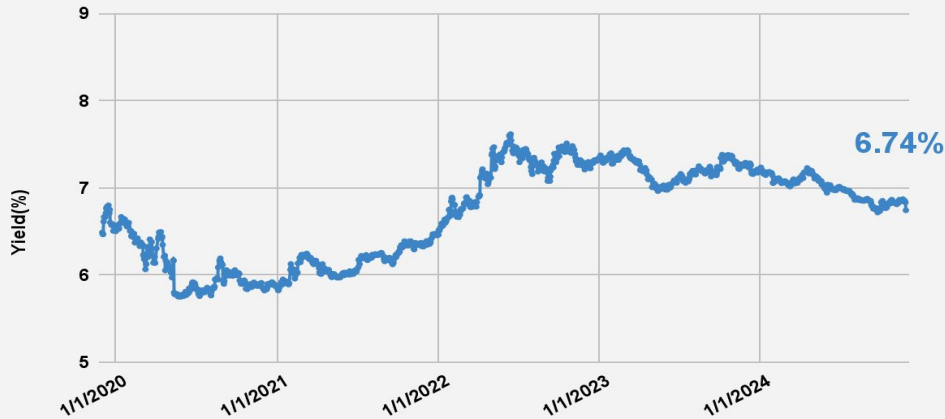

### India 5-Year Gov. Bond Yield (%)



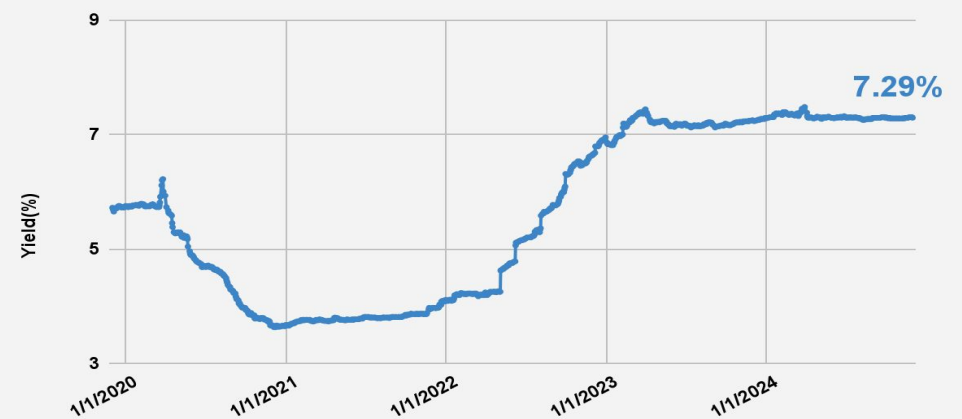

### India 10-Year Gov. Bond Yield (%)

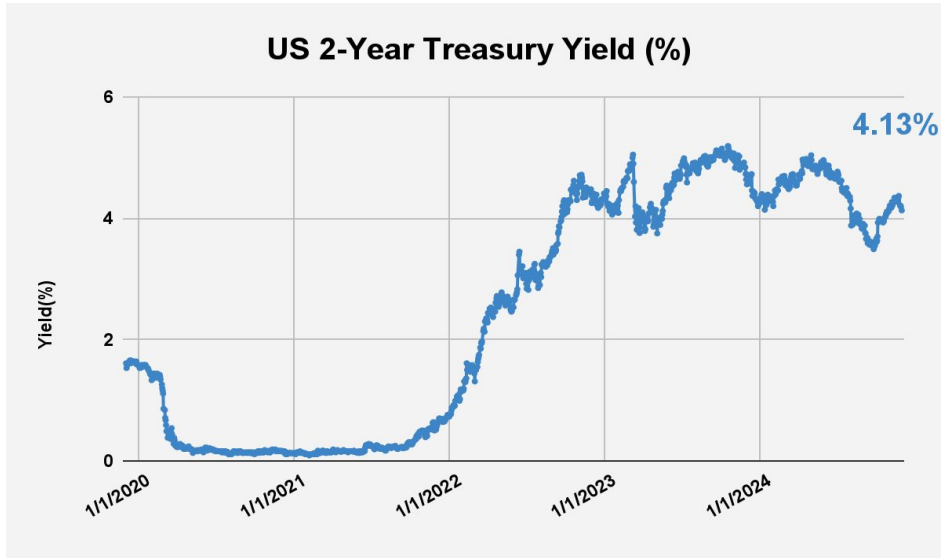

### India 3-Month MIBOR (%)



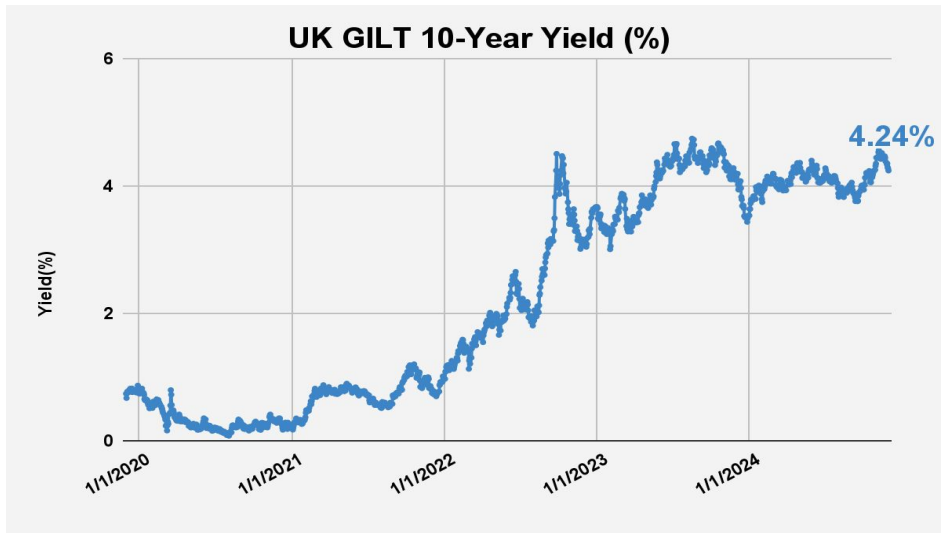

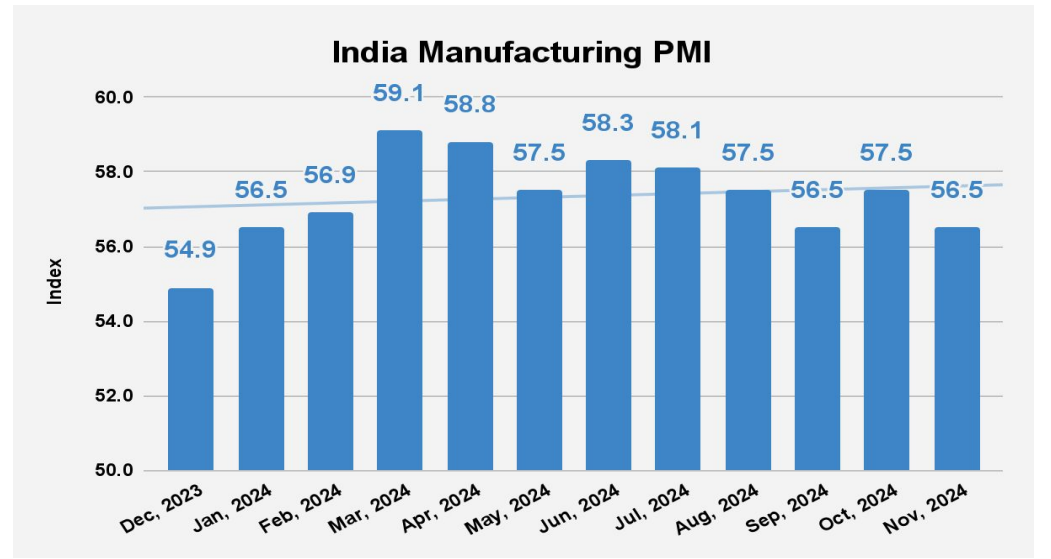

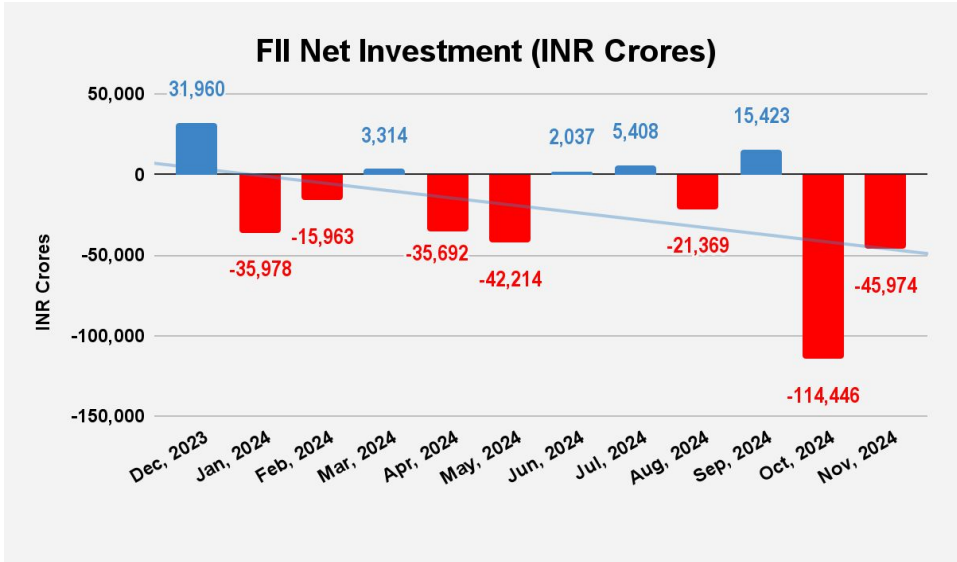

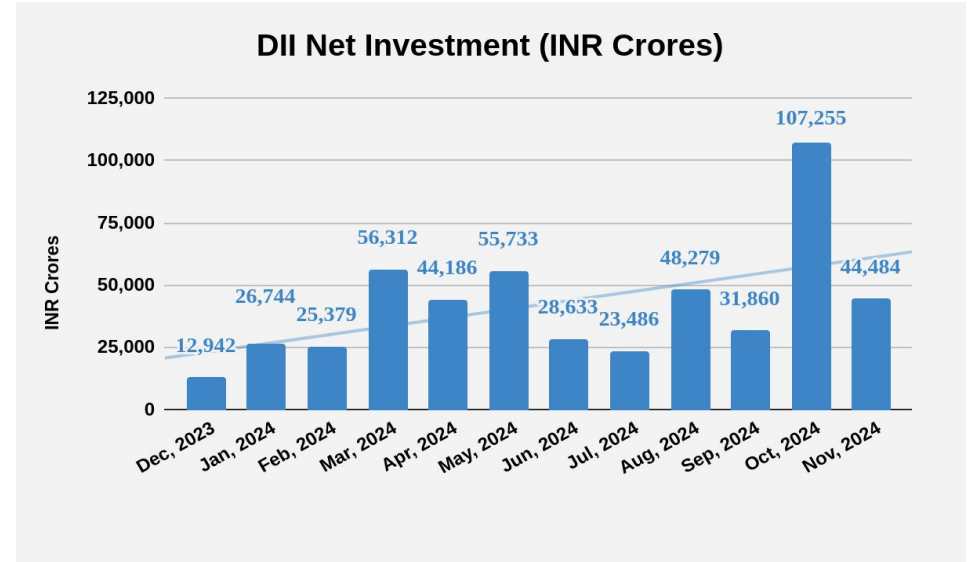

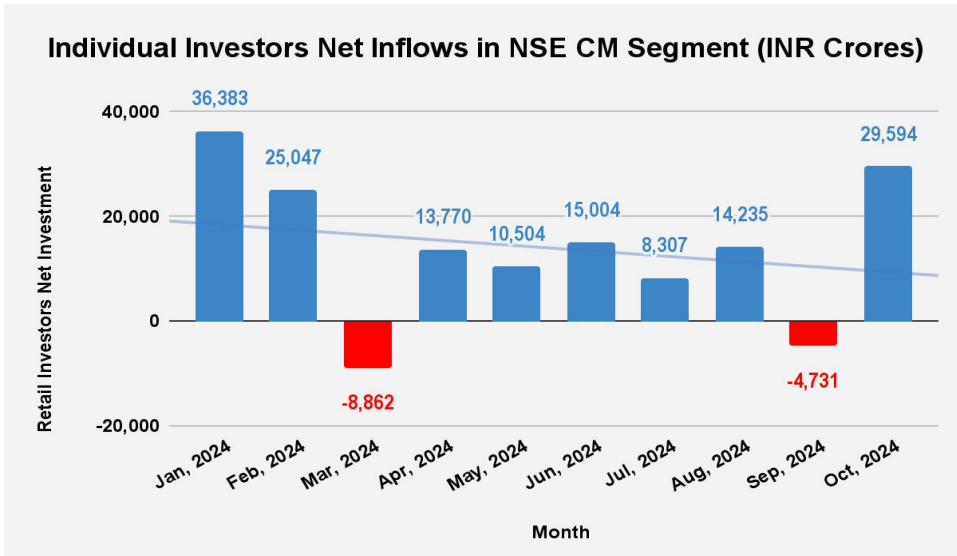

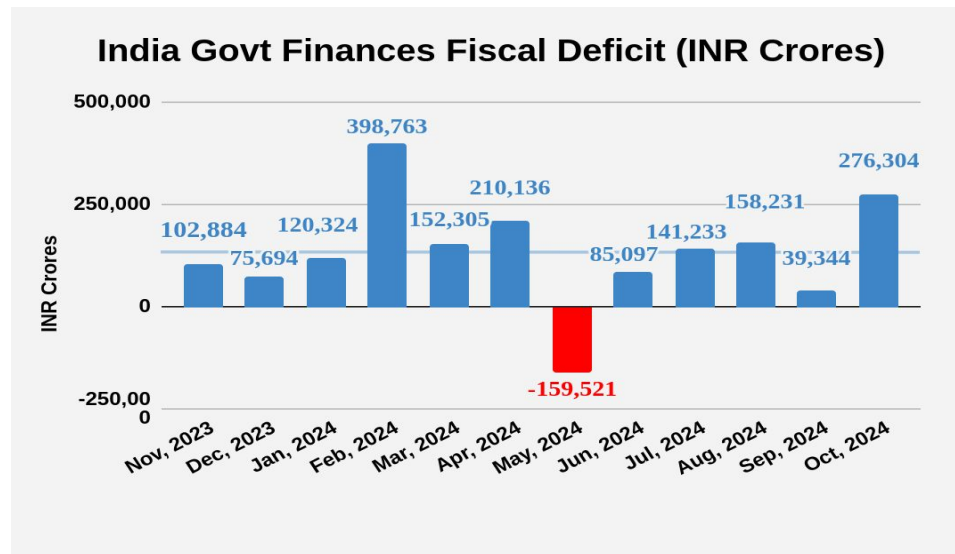
